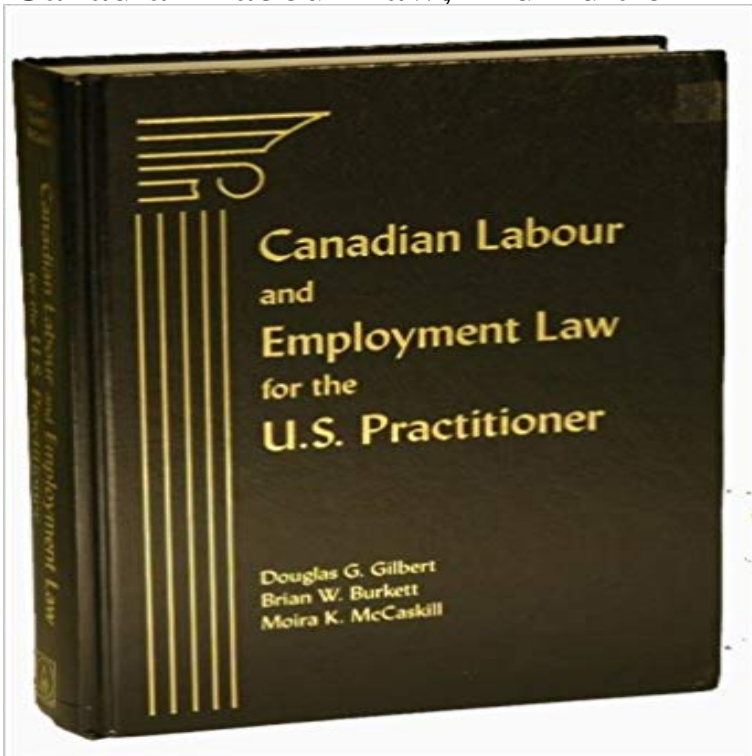


Canadian Labour Law, 2nd Edition
